

## **FLLS Board of Trustees Meeting Minutes**

Wednesday, April 20, 2022 at Finger Lakes Library System, 1300 Dryden Road, Ithaca, NY.

**PRESIDING** President Toombs called the meeting to order at 5:30 PM.

(DOC 22 22) AGENDA: No conflicts of interest were reported by any Trustees present.

The minutes from the Mar. 16, 2022 meeting were accepted as presented. – Motion by Moolin. (DOC 22 23)

(DOC 22 24) The Director's Report was discussed.

## **New Business:**

(DOC 22 25) Sarah went over FLLS' Annual Report for 2021, which was accepted as presented. - Motion by Mannino.

(DOC 22 26) Sarah gave an update on the recently passed NYS budget.

(DOC 22 27) Steve Moolin's resignation was unanimously, though regrettably, approved. – Motion by Mannino.

(DOC 22 28) Sarah went over the details of the Polaris Vega service, an addition to our catalog software platform.

> Member libraries were heavily in favor of it but worried about the cost. Rex had negotiated a substantial discount and five-year lock of pricing. The proposal is for FLLS to absorb 75% of the added cost. After discussion, the proposal was unanimously approved. – Motion by Mannino

The Finance Committee proposed that FLLS give

- a. A pay increase of 3% to all non-union staff, retroactive to January 1, 2022. Unanimously approved.
  - Motion by Heavenrich
- b. A reimbursement to an individual staff member who has chosen not to receive health insurance through FLLS, at the rate of 90% of the cost (up to the maximum charge that FLLS pays for single coverage insurance). Unanimously approved. - Motion by Heavenrich

**Next Meeting:** The next public meeting of the Trustees will be May 18, 2022.
