# FROM THE DIRECTOR

The 66<sup>th</sup> Annual Meeting of the Finger Lakes Library System was held on Friday, October 18 at the new Ithaca Conference Center. Almost 100 library directors, staff and trustees joined us for our annual meeting. It was so nice to see everyone come together to learn, share ideas and network with each other!

During our business portion of our meeting, we heard from Edith B. Ford Memorial Library Trustee, Jean Currie. Jean also is Chair of the Library Trustee Association Section of NYLA (New York Library Association) and she spoke about the importance of trustee education and the benefits of becoming involved in LTAS.



The election of three trustees to the Finger Lakes Board of Trustees occurred. The terms of those elected begin on January 1, 2025. The following trustees were elected:

**Stevan Knapp** – At-Large trustee. Stevan’s term is for one year, as he is completing a prior trustee’s term. Stevan was appointed to the FLLS Board in June 2024 and is finishing the term previously held by Cynthia Mannino.

**Cynthia Mannino** – Tompkins County trustee. Cynthia’s term is for one year, as she is completing a prior trustee’s term. Cynthia has been serving as our at-large trustee since 2020. She resigned from that role in June and was appointed to represent Tompkins County (finishing the term previously held by Liz Hudson). This was done so Stevan Knapp could be appointed to the at-large position.

**Kristina Furi** – Cortland County trustee. Kristina will be starting a five-year term. In addition to serving on our board, Kristina is also a member of the Cortland Free Library Board of Trustees and a member of their ad hoc committee working on the unhoused population support. Kristina is Cornell University’s Community Response Team Coordinator and has previously worked as a child protective services caseworker.

Our annual meeting speaker was Matthew Burr, who gave the presentation “Human Resources Basics for Directors and Trustees”. Matthew is a human resources and operational consultant, and the owner of Burr Consulting, LLC. The presentation offered tips for onboarding new staff, how to make sure you are meeting HR compliance requirements, items for a library’s personnel manual, and how to make sure policies are up to date. Matt also built in time to discuss first-hand accounts of HR successes and challenges in our libraries.

A very large thank you to FLLS staff and trustees who helped us plan our annual meeting. A special thank you to Diana Leigh, our administrative assistant, did such a tremendous job finding our space this year, as well as choosing our menu and making sure registration ran smoothly. Our staff’s hard work made our meeting a tremendous success.

A quick note that I will be out of the office and on vacation on Thursday, October 31 and Friday, November 1.

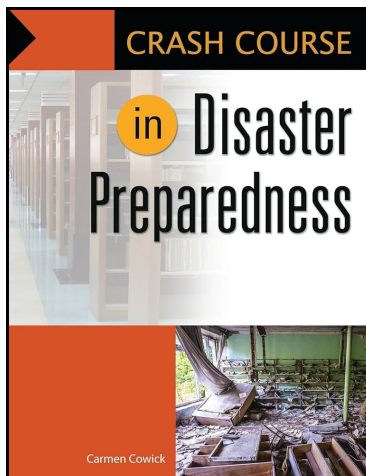

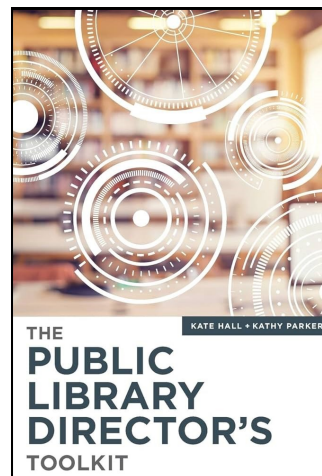

# AWARDS & GRANTS

## [Apply Now: Libraries Transforming Communities: Accessible Small and Rural Communities](#)

The American Library Association invites applications from small and rural libraries for the third round of funding of the [Libraries Transforming Communities: Accessible Small and Rural Communities](#) grant. The initiative will offer 3.5 million in grants to small and rural libraries to increase the accessibility of facilities, services and programs to better serve people with disabilities. In February 2024, ALA announced it received an additional \$10 million dollars in support of the LTC: Accessible Small and Rural Communities initiative. A substantial portion of the funding – \$7 million – will be distributed in grants of \$10,000 and \$20,000 to small and rural libraries.

[Library workers may now apply online for funding from September 11, 2024, to December 11, 2024.](#) **Up to 300 libraries will be awarded in this application period.** Previous awardees from round one and/or two are eligible to apply. Note that prioritization will be given to applicants not previously awarded.

Libraries selected for round three will receive \$10,000 or \$20,000 to support costs related to their community engagement project; virtual training to assist project directors in developing their community engagement, facilitation, and disability service skills; a suite of online resources developed to support local programs; and technical and project support from the ALA Public Programs Office throughout the grant term.

Libraries chosen to participate in LTC: Accessible Small and Rural Communities will first conduct community input-gathering sessions to assure that their work aligns with local disability community needs. Libraries will be required to identify the primary audience they are hoping to reach (e.g., older adults with mobility disabilities, children with autism, Deaf community members) and facilitate a community conversation with the impacted patron group to guide improvement of the library's services. Grantees will then use the grant funds to create services or improve their facilities based on the needs identified by their audience.

The opportunity is open to libraries serving small and rural communities in the U.S. and U.S. territories. To be eligible, a library must be located in an area that's more than, or equal to, five miles from an urbanized area and with a population of 25,000 or less, in keeping with Institute of Museum and Library Services (IMLS) definitions of small and rural libraries.

*Since 2014, ALA has distributed Libraries Transforming Communities funding to foster community engagement skills among library workers and support need-driven projects. Libraries Transforming Communities: Accessible Small and Rural Communities is part of ALA's longtime commitment to preparing library workers for the expanding role of libraries. The initiative is offered in partnership with the Association for Rural & Small Libraries (ARSL). It is supported by a private donor.*
