## Sustainable Funding

A new year means resolutions...and referendums! Trustee responsibilities are small in number but broad in scope. A key responsibility of your board is to secure adequate and sustainable funding so the library can fulfill its mission. One way many of our member libraries achieve this is through a referendum. January is the time to begin the process if you're starting fresh or asking for an increase

NYS allows libraries to request funds directly from school district taxpayers by asking them to vote on a resolution placed on the annual school budget vote. This is the definition of a "school ballot referendum". School district taxpayers pay an amount based on their assessed property value. Referendums are a form of sustainable funding for libraries because once your community votes "yes", your library receives those funds every year. Your library can decide to ask for more funding as needs develop.

To be clear, library referendums do not affect the school budget and are not part of the school budget. Rather, the existing school budget vote is a tax collecting mechanism already in place that makes it easy to ask taxpayers to support the library.

When one library within a school district decides to go for a referendum, we recommend that other libraries in the same district do so as well since all school district taxpayers will be responsible for paying the library tax even if the library in their community does not participate. The more libraries that participate within a school district the more likely the referendum is to pass.


